

UNDERSTANDING REOMi

1-WHAT IS REOMi ?

Tax collection household waste incentive, will become the only funding method for the waste treatment service, starting from the first of January 2024 for the 36 municipalities of the Communauté de communes du Minervois au Caroux (CdCMC), replacing the TEOM, Garbage collection tax (linked to the property tax transmitted by the tax department), or the REOM, where we pay according to the number of people per household.

It will cover all the expenses related to the waste treatment: collection and processing of household waste, paper, glass, rubbish recycling site, renewal of equipment, etc.

2-WHY CHANGING ?

1/ By regulatory obligation

Currently with 3 pricing systems, the Minervois to Caroux, the Comcom has the obligation to harmonize.

2/ To cope with the rising costs

This new system will lead to a change in our habits, but it is the most effective way of controlling the explosion of our waste bill.

3/ To reduce our waste

The system allows to MEASURE the amount of waste emitted by each household, and to apply a more accurate billing.

Billing is partly based on consumption, as has been the case for a long time for water, gas or electricity.

Today, almost 2/3 of our household waste can be recycled. By adopting the right gestures now, I'm doing something for the planet, but also for my wallet !

3-HOW DOES IT WORK ?

During January 2024, the rubbish bins will be progressively removed. From December 2023, household waste columns will be installed next to the sorting columns. The number of garbage bags dropped off will be counted per household, using an access badge.

And what about the professionals ?
Depending the activity, strongly producing waste or not, each professional will have:

- Either a badge
- Or a locked bin, which will be collected separately.

MY COLUMN ACCESS BADGE

My badge is linked to my home, whether I'm the tenant or the owner-occupier. It allows me to activate the opening of the 200 columns of the 36 communes from the Minervois Caroux area.

The sorting bins remain freely accessible.



How to withdraw my access badge

A distribution is planned in my municipality in December 2023. If I am unable to go there, I will appoint a person of trust to collect it. Otherwise, I could retrieve it later by contacting the Community of Communes.

4-WHAT IS INCLUDED IN MY REOMI INVOICE ?

• A FIXED PART

- Access to the waste services :
 - o Collecting and processing of packaging, paper and glass
 - o Residual household waste collection
 - o Composters available at preferential prices
 - o Free loan of garden shredders
- Access to the drop-off centres
- Treatment of household waste: includes 26 openings per year for a 30-litre bag

• A VARIABLE PART

Charged for each additional bag deposited in the column beyond the 26 pre-billed openings.

Billing is partly based on consumption, as has been the case for a long time for water, gas or electricity.

2 Invoices a year :

- One for the 1st semester, which I receive in the 3rd trimester
- A 2nd for the 2nd semester, received at the beginning of the following year

• The **annual flat** rate is set at **€185**

Including

- A fixed part covering fixed costs such as collection, selective sorting and waste collection centres, the supply of badges, maintenance of equipment, etc.
- A flat-rate share including the 26 openings.

• The **variable part** will be charged **€1.25**
